You may transfer your scores on the National Physical Therapy Examination any time after you initially receive your score. Your scores are automatically reported to the board in the state (jurisdiction) in which you are seeking licensure and which you paid to take the examination. There is a reporting fee only when you transfer your scores to other states jurisdictions.

Transfer Information
